

PRIVACY NOTICE ON INTERNET ACCESS OF VISITORS

This Privacy Notice aims to inform you about the processing of your personal data in accordance with Article 10 of the Law on Protection of Personal Data numbered 6698 (“LPPD”).

Mey İki San. ve Tic. A.Ş. located at Bykdere Cad. Bahar Sok.No.13 River Plaza – İstanbul (“we”), processes your personal data in accordance with the Law on Protection of Personal Data as data controller under the below-mentioned scope. For more information, please view our policies and privacy notices on our website.

a) Purpose of Processing

We process your name, surname, telephone number, e-mail address and online identifiers data such as IP address, MAC address to fulfill our obligations within the scope of the Law on Regulation of Publications on the Internet and Combating Crimes Committed by Means of Such Publications (“the Internet Law”). We process your personal data for the following purposes:

- providing you with internet service,
- fulfilling our legal obligations and keeping records of internet access and use,
- preventing unauthorized internet access,
- planning and executing security measure activities,
- fulfilling our transactions/records/notices which are legally required,
- conducting information security activities,
- creating and monitoring visitor records.

b) Transfer of Personal Data

We may transfer your personal data to authorized public institutions and individuals for the above-mentioned purposes and based on the legal basis specified in Article 8 and 9 of the LPPD.

c) Collection Methods and Legal Basis

We will collect your personal data manually or automatically through electronic environment such as telephone, computer and other devices in order to fulfill our legal obligations (Article 5/2() of the LPPD).

d) Retention of Personal Data

We are required to retain your above-mentioned personal data for two (2) years in accordance with the Internet Law. We will erase, destroy or anonymize your personal data upon the end of such purpose of processing.

e) Your Rights

Under Article 11 of the LPPD you are entitled to:

- learn whether your personal data is processed or not,

- request information if your personal data is processed,
- learn whether your personal data is used for its purpose of processing,
- know the third parties to whom your personal data is transferred within Turkey or abroad,
- request the rectification of your incomplete or inaccurate personal data, if any, and request notification of the operations to whom your personal data has been transferred, in case of rectification,
- request the erasure or destruction of your personal data, even if the processing is in accordance with the Law numbered 6698 and relative other provisions of law, if the purposes for processing your personal data has been dissolved, and request notification of the operations to whom your personal data has been transferred,
- object to the processing, exclusively by automatic means, of your personal data, which leads to an unfavorable consequence for you,
- request compensation for the damage arising from the unlawful processing of your personal data.

You can submit your requests by filling out the *Data Subject Application Form* on our website. Your request will be responded free of charge. However, if your request requires additional costs, the fees in the tariff set by the Personal Data Protection Board will be charged to you.
